#### Notification of Source of Distributions

Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the monthly dividend payment of \$0.085500 per share payable on October 16, 2024, to shareholders of record on October 15, 2024, it is anticipated that 31% of such dividend will be a return of capital.
