Professor or Associate Professor, one position for female researcher

2. Affiliation: Center for International Collaborative Research (primary duty) and Office for the Development of Interdisciplinary Research Strategy (secondary duty), Institute for Space-Earth Environmental Research

3. Background and requirements:

(1) About ISEE: The Institute for Space-Earth Environmental Research (ISEE)^{*1}, Nagoya University, conducts studies to elucidate the mechanisms and interactions of various phenomena in the holistic Earth, Sun, and Universe system. The mission of ISEE is to contribute to solutions for global environmental problems facing humankind and to the progress of human society spreading into space through the integration of space science and earth science. ISEE plays a unique role in linking these disciplines as one of Japan's Joint Usage / Research Centers*2 and promotes a wide variety of collaborative research. To realize this mission, ISEE has organized seven research divisions, three research centers, and Office for the Development of Interdisciplinary Research Strategy (ODIRS)*4. The seven research divisions of ISEE are 1) integrated studies, 2) cosmic ray research, 3) heliospheric research, 4) ionospheric and magnetospheric research, 5) meteorological and atmospheric research, 6) land-ocean ecosystem research, and 7) chronological research. One of the three research centers, the Center for International Collaborative Research (CICR)*3 promotes various international collaborative research to understand physical mechanisms occurring in space, sun, and earth systems. The ODIRS serves as a bridge connecting space science and earth science, exploring new possibilities from an interdisciplinary and strategic perspective.

(2) Job details:

(Immediately after being hired): The successful candidate is expected to conduct research related to at least one of these seven divisions. In addition, in the CICR and ODIRS, the candidate will take a lead to develop ISEE as an international joint research center (i) by hosting international collaborative research, (ii) by hosting international meetings, (iii) by promoting the exchange of researchers between ISEE and foreign institutions, and (iv) by organizing capacity-building schools for students and young scientists. For this purpose, we are particularly interested in receiving applications from those who have long teaching and research experiences under nonJapanese environment, and/or those who have received their undergraduate or graduate education under non-Japanese environment. The candidate is also expected to be actively involved in education for graduate and/or undergraduate courses in English, and to work for joint research with domestic and international researchers, fully understanding the ISEE's mission as a Joint Usage / Research Center. As a faculty member of ISEE, the candidate will contribute to the management and administration of the institute and the university.
