TOKYO, June 18, 2024 -- Trend Micro Incorporated (TYO: 4704;TSE: 4704), a global cybersecurity leader, today announced the status of the repurchase of shares of its common stock under Article 459, paragraph (1), item (i) of the Company Law of Japan. And this buyback program, approved pursuant to a resolution at the board of directors meeting on February 15, 2024, has finished.
