Award: Meritorious Unit Commendation

Period of service: 12 March 2010 to 10 March 2011

Authority: AR 600-8-22, paragraph 7-15

Reason: For exceptionally meritorious service. During the period 12 March 2010 to 10 March 2011, the 43d Sustainment Brigade and its subordinate units displayed exceptionally meritorious service in support of Operation Enduring Freedom. The 43d Sustainment Brigade and its subordinate units identified major gaps that existed between national and tactical processes for readiness and material management: maximized effective throughput of troops, supplies and material through intra-theater hubs by establishing a comprehensive Kandahar throughput plan; and building enduring sustainment solutions for the Combined Joint Operations-Afghanistan by publishing the first logistics campaign plan in southern Afghanistan. The unit's commitment to increase the logistics proficiency of Afghan National Security Forces set the conditions for the eventual withdraw of Coalition Forces from Afghanistan. The unit's mission execution and commitment to excellence set a new standard for sustainment operations in Afghanistan for Regional Commands South, Southwest and West. The 43d Sustainment Brigade and its subordinate units' actions are in keeping with the highest military traditions and reflect great credit upon its Soldiers, the 43d Sustainment Brigade, the Joint Sustainment Command-Afghanistan and the United States Army. CMH will use this permanent order to authorize the manufacture of an appropriate decoration streamer for any organization clearly entitled to display the award. The streamers will then be manufactured and sent to the U.S. Army Human Resources Command for automatic distribution to the units concerned. It is not the responsibility of HRC to replace streamers that are lost or damaged.
